## SHIPPING PROMISES:

All agreements as to delivery are subject to the contingencies of floods, fires, strikes, accidents or other causes of delay beyond our control. In the event of the occurrence of any such contingencies and its consequent inability to supply to total demands for Atlas Copco products. The Company may allocate its available supply among any and/or all Buyers, as well as departments and divisions of the Company, upon such basis as the Company may deem fair and practical, without liability for any failure of performance which may result there-from.

Delivery to a common carrier or licensed trucker shall constitute delivery to Buyer and all risk of loss or damage in transit shall be borne by Buyer.

The shipping date specified in the proposal may be an approximate date based on current production conditions.

The Seller will not be liable for any damages suffered by the Buyer due to non-delivery of equipment or material covered by this quotation

Shipment delays for reasons beyond our control, due to lack of engineering information, process changes, or inability to obtain tryout parts, will subject prices to inflationary factors relative to a new, extended delivery date.

# PLACEMENT OF ORDER:

Place orders with the Atlas Copco Tools and Assembly Systems Customer Center from which you received the proposal. Please reference current proposal number and part numbers on proposal. Unless otherwise stated in this proposal, the prices quoted herein are exclusive of all sales, use, and similar taxes and, whenever applicable, such taxes will be added to the invoice as separate items.

## **FORCE MAJEURE**

Any delay or failure by the Seller to perform its obligations hereunder shall be excused if, and to the extent that it is caused by an event or occurrence beyond the reasonable control of the Seller and without its fault of negligence, such as, by way of example and not by way of limitation, acts of God, actions by any governmental authority (whether valid or invalid), fires, floods, windstorms, explosions, riots, natural disasters, wars, sabotage, labor problems (including lockouts, strikes and slowdowns), inability to obtain power, material, labor, equipment or transportation, or court injunction or order; provided that written notice of such delay (including the anticipated duration of the delay) shall be given by the affected party to the other party within ten (10) days.
